



Guidelines for Life Membership of the Carillon Society of Australia.

Preamble

The process for Life Membership of the Carillon Society of Australia is that a current member of the Carillon Society of Australia nominates a current, or past member of the Carillon Society of Australia for life membership of the Society, presenting evidence of their contribution to the Executive Committee of the Carillon Society of Australia. It is important to note that while contributions to individual towers may be significant, Life Membership of the Carillon Society of Australia reflects the contribution made to this national organisation.

From the constitution: "Life membership can be awarded to an individual as determined by the executive committee and no fee is charged."

Here's a more detailed breakdown of common criteria that could be addressed. A nomination does not have to meet all criteria, and this list is not exhaustive.

General Criteria:

- Length of Service:** A significant period of membership and/or service, often a minimum of 10 years.
- Outstanding Contribution:** The nominee should have demonstrated exceptional service or contributions that have benefited the Carillon Society of Australia and its members.
- Loyalty and Dedication:** A demonstrated commitment to the Carillon Society of Australia's values and goals.
- Measurable Benefit:** The contributions should have had a positive and noticeable impact on the Carillon Society of Australia.

Specific Areas of Contribution:

- Leadership Roles:** Holding positions on the Executive Committee or sub-committee/s, or other leadership roles within the Carillon Society of Australia.
- Volunteering:** Regular and consistent volunteering for Carillon Society of Australia activities, or projects.
- Fundraising:** Contributing to the Carillon Society of Australia 's financial stability through fundraising efforts.
- Promotional Activities:** Helping to promote the Carillon Society of Australia and its activities to the wider carillon community.
- Mentoring:** Providing guidance and support to new or younger members.
- Representation:** Representing the Carillon Society of Australia in a positive and professional manner.
- Social Functions:** Contributing to the social aspects of the Carillon Society of Australia.
- Development Activities:** Working to improve the Carillon Society of Australia's programs and services.
- Quiet Achievers:** Recognition of individuals who may not be vocal or hold senior positions but make significant contributions.

Nomination and Award Process:

- Nomination:** Nominations for life membership are typically submitted in writing by current Carillon Society of Australia members to the Executive Committee.
- Review Committee:** The Executive Committee will review nominations and make recommendations.
- Voting:** The Carillon Society of Australia's 's members or executive committee may vote on the nominations.
- Presentation:** The award of life membership to be presented at a Carillon Society of Australia event or meeting.
